## **COLLISION AVOIDANCE TRAINING (C.A.T.)**

Is there a licensed teenage driver in your household? C.A.T. is a defensive driving and vehicle control program for drivers ages 16-20. It includes classroom and behind-the-wheel instruction. This one day program is designed to provide knowledge and understanding of how vehicles respond in certain situations and how to regain control of the vehicle. Participants learn evasive maneuvers, emergency braking and skid and off -road recovery. The fee is \$95.
