IT'S TIME TO REGISTER FOR KINDERGARTEN

Kindergarten is mandatory in MD. State law requires that children entering kindergarten in the fall of 2024 must be 5 years old on or before Sept 1, 2024. Parents or quardians are to register students at the school currently serving the address where the child's parent or guardian resides. 
